

- UST 10s closed today at **4.135%**. Our 1st weekly resistance zone is **4.12% - 4.13%** (**90%** shot to hold) and our 2nd weekly resistance zone is **4.085% - 4.095%**. Our 1st monthly resistance zone of **4.035% - 4.065%** has held for 10 months.
- Our 1st weekly support zone is **4.22% - 4.23%**.


Jim Bianco: Corporations own less than 2% of all homes, and some measures have it at less than 1%. They are a popular scapegoat, but this was never the problem.
