US Treasuries


- UST 10s on Thursday closed at **4.25%**.

- Our 1st monthly support zone is **4.245% - 4.27%** (**69%** shot to hold).
- We have a 1st weekly resistance zone of **4.155% - 4.165%**.

Weekly Initial Claims





Rolling 4-Week Average






