 - Looking ahead for the week, we have a 1st weekly resistance zone of **4.20% - 4.205%** (63% shot to hold) and a 2nd weekly resistance zone of **4.155% - 4.16%** (50% shot to hold).
 - Our 1st monthly resistance zone is **4.035% - 4.065%** which has held for 30 months.
 - We have a 1st weekly support zone of **4.285% - 4.29%** (60% shot to hold).

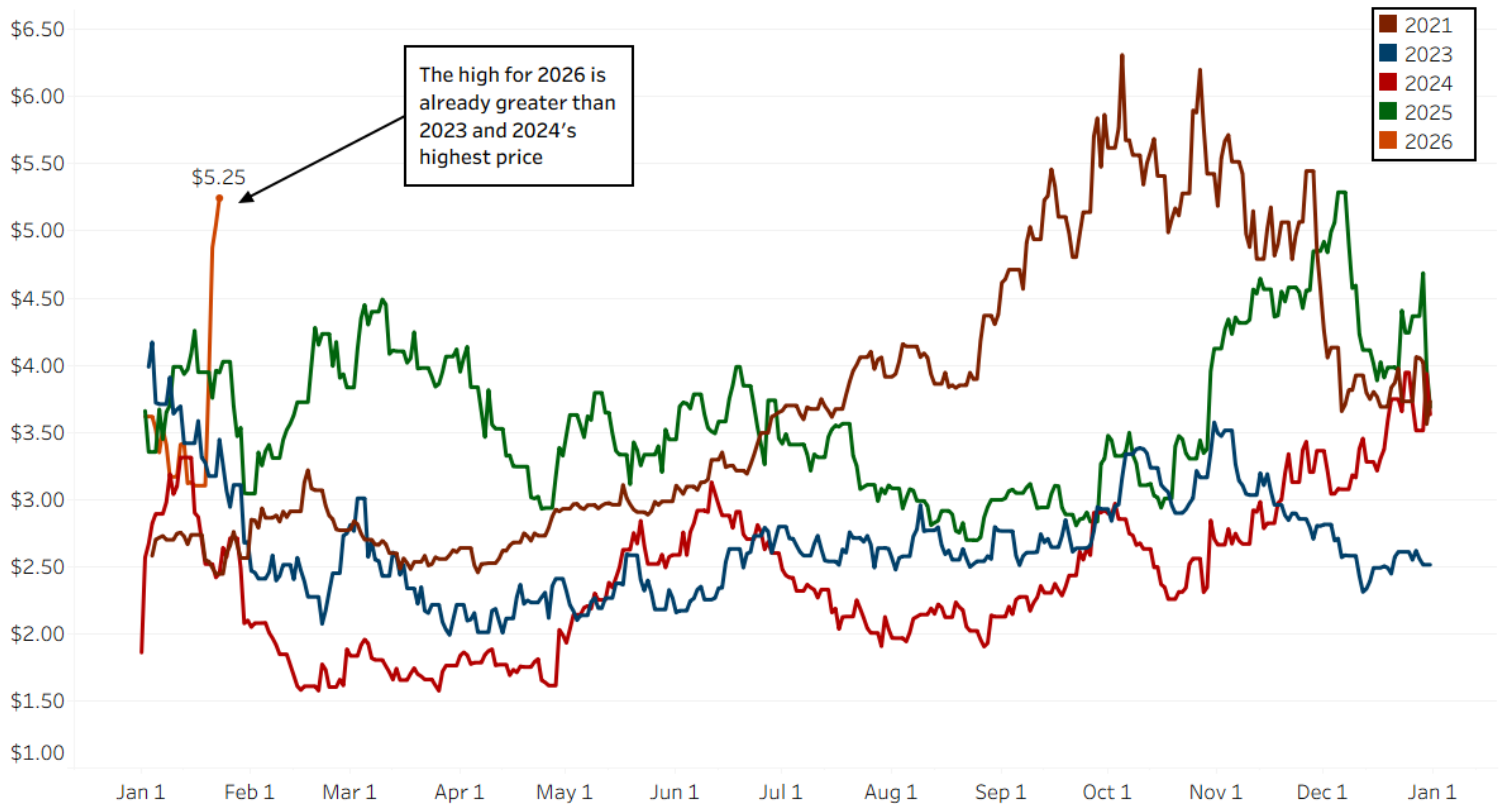
